

Job Description: Programme Manager - Digital Partnerships

Reports to: Head of Programme – Cyber, Digital and Technology

Job Purpose:

To manage and coordinate the Digital Partnerships Programme with the core objective of fostering and driving digital transformation initiatives across local government.

Core Accountabilities:

- 1. Lead the design and delivery of complex digital policy and improvement projects aligned with the LGA's Business Plan and local government priorities.
- 2. Build and maintain high-level partnerships with councils, central government, industry and academia to promote secure, inclusive and innovative digital transformation.
- 3. Represent the LGA in senior-level forums, consultations and working groups, ensuring local government perspectives are reflected in national policy.
- 4. Provide line management and professional development support to Digital Advisers, ensuring effective delivery of their responsibilities.
- 5. Contribute to the strategic direction of the Cyber, Digital and Technology team, supporting cross-cutting initiatives and collaborative working.
- 6. Model the LGA's values and uphold its commitments to equality, diversity, inclusion, and sustainability.
- 7. Undertake other duties appropriate to the role as required.

Specific Accountabilities:

- 1. Lead the development of policy positions and strategies championing local government on key digital issues, including AI, inclusion, ethics, sustainability, connectivity, market engagement, supply chain optimisation, procurement, data policy, and data sharing initiatives.
- 2. Working closely with other Team Leaders, lead the development of support and improvement initiatives for councils to address challenges and barriers to digital transformation, and to promote digital inclusion.

- 3. Lead the development and implementation of the LGA's support offer to councils on AI ensuring that it's responsive to varied sector needs, and Government stakeholders such as MHCLG and DSIT.
- 4. Commission and oversee research and analysis to inform evidence-based policy development and support sector improvement.
- 5. Manage relationships with senior stakeholders in government departments, regulatory bodies, and technology partners to influence digital policy and funding decisions.
- 6. Oversee the planning and delivery of high-profile events, roundtables, and workshops to engage councils and stakeholders in shaping digital policy.
- 7. Ensure effective knowledge sharing across the sector by capturing and disseminating good practice, case studies, and lessons learned.
- 8. Provide high-quality briefings, reports, and presentations to senior audiences, including LGA leadership, elected members, and external partners.
- 9. Support the Head of Programme in strategic planning, resource allocation, and reporting on programme impact and outcomes.

The team are also responsible for the LGA's support offer to councils on AI, which has included developing our case study bank, our AI unpacked videos, leading the State of the Sector AI programme, and working closely with i.AI to support a 25 council pilot of the tool Minute. This role will be responsible for responding to sector needs and continually delivering high quality support to councils. Beyond this, you'll contribute to the broader Cyber, Digital and Technology programme, working with a dynamic network of stakeholders to advance our ambitious digital agenda.
